2024 Summer Contract effective July 1, 2024 - August 23, 2024.

Welcome to the Clinton Path Preschool Summer Program! Please read through this contract carefully as it contains pertinent information regarding your child's enrollment.

- The Clinton Path Preschool Summer Program regular day program will run from **July 1st to August 23rd 2024**, Monday through Friday, 8:00 am to 12:30 pm.
- Children are invited to stay for Lunch Bunch from 12:30-1:30 for \$15 per day.
- Extended Day is available from 12:30 pm to 4:30 pm for an additional fee. You can sign up for Extended Day in advance or on a drop-in basis, subject to availability of space.
- To help children acclimate, we recommend enrolling for 5 days initially.
- A non-refundable deposit of \$260 is required to reserve your child's spot. \$10 of this is an application fee, while the remaining \$250 will be applied to your summer tuition balance.
- Tuition is due in full and all enrollment forms and other required materials must be submitted prior to your child's first day of attendance
- Please note that applications will be accepted at a discounted rate before May 1st. If you are enrolling two or more children on the same days, there is a sibling discount of \$10 off for the second child and any additional children.
- Tuition is non-refundable and transfers are not available for withdrawal, failure to attend, or incomplete attendance. Once your days are confirmed, we cannot guarantee the opportunity to drop or switch days.
- You may add additional days throughout the summer, space permitting. Payment is due upon signup before your child attends the days that are added.
- If you initially signed up by May 1, the added days will be assessed at that tuition rate, \$85 for the morning session and \$55 for extended day.
- Enrollment for the Clinton Path Preschool Summer Program is open until capacity is reached. While we cannot guarantee that all scheduling requests will be accommodated, we will do our best to accommodate each family.
- To best support each child and their individual needs, parents are required to inform the CPP Director of any outside support services their child currently receives or is scheduled to receive prior to their start date at the Clinton Path Preschool Summer Program.

By signing below, Clinton Path Preschool and the parent(s) of the above named child agree to all CPP Summer Program policies as stated in this enrollment contract. Failure to return all completed and signed forms may result in your child's inability to join the Summer Program.
